Recipients: Retired or elderly persons who received Employees' Pension Insurance or National Pension during 2025.

Others: Residents in Nissin City. Free of charge.



School club activities are changing (変わりゆく「学校の部活動」)

After-school club activities have long been a big part of life for school children in Japan. However, they are undergoing great changes nationwide, especially for junior high schools, against the backdrop of declining birthrate and work style reform for teachers. Instead of being held at each school, they are now expanding to cover a wider local area.

Local clubs will act as independent organizations apart from schools. Since they are not school club activities, participants of local clubs need to pay the cost to manage the club including payment to leaders or coaches. We would appreciate citizen's understanding and cooperation to support the continuance of children's activities. While each local club needs to handle management, finances and schedule arrangements, they can expand their activity widely based on their own ideas apart from school. Now, Nisshin City and the board of education are working together with schools, communities, and guardians to build a new system for children's activities. We are inviting local clubs and leaders to join us in our endeavors, as the number of times club activities are held at junior high schools will decrease in 2027. We would appreciate your understanding on this transition of children's activities and look forward to having you join us in our efforts.

Information on Final Returns for Income Taxes (所得税の確定申告のご案内)

We recommend you file your tax return at home via the e-Tax website using your smartphone and My Number Card. The period for filing tax returns is from February 16 (Mon) to March 16 (Mon).

Note: To receive consultation at the filing sites you must make a reservation in advance.

Please check the Nisshin City website and flyers placed in Nisshin City Hall and public facilities in Nisshin for details including how to apply and required documents for filing.

*Category of tax return

Consultation with a tax accountant covers persons who have income from businesses, real estate and agriculture.

A-category tax return covers persons who have only salary, pension and other income, dividends and occasional income.

Note: The following persons cannot file a tax return at Nisshin City Hall. Please go to the site set up by the tax office.

- 1) Persons who make a declaration for capital gains on land, building and stock, future trading income, donation tax and inheritance tax
- 2) Persons who make a declaration on tax returns on or before 2024, or on behalf of someone who has died or left Japan
- 3) Persons who make a declaration on their first special deduction for housing loans
- 4) Persons who make a declaration to be eligible for foreign tax credit, deduction for dependents who reside outside Japan, and deduction for casualty losses
