Declaration of Municipal & Prefectural Residents' Taxes

(市・県民税の申告について)

Based on your declaration for 2025, the declaration forms for municipal and prefectural residents' taxes will be sent by post at the end of January 2026. People living in Nisshin City as of January 1, 2026 who had income from January to December 2025 are required to declare their income status to Nisshin City as necessary. Persons who are planning to file a final return for income tax for 2025 are not required to declare for residents' taxes. The forms are available from February 1 at the window of Taxation Div. if you need them.

[How to Submit] Submit the form to Taxation Div. by March 16 (Mon) 2026. The forms may also be submitted by mail.

Nationwide Information Transmission Drill Using J-ALERT

Disaster prevention sirens will be sounded in Nisshin City on February 6 as part of the nationwide drill using J-Alert, the National Early Warning System. A fourteen-second siren followed by a pause will be repeated three times.

[Date and Time] February 6 (Fri) around 11:00 a.m.

[Place] Nisshin Citizens Hall, Nisshin Nishi Junior High School, Takenoyama Elementary School, Ainoyama Elementary School, Higashi Elementary School, and Sagamine Reservoir

Note: The drill may be canceled in case of earthquake, storm or flood. Cancellation will be notified on the Nisshin City Website.

Though the handling fees for obtaining copies of the Certificate of Residence, Certificate of Seal Registration and Certificate of Income at convenience stores is presently 100 yen per certificate, this discount will end on March 31, 2026. The fees at convenience stores will be restored to the regular price of 300 yen per certificate. If you need to obtain a certificate on or after April 1, please be aware of these changes.

National pension insurance premiums can be paid in cash, by bank transfer, or by credit card.

You can get discounts by prepayment of insurance premiums for 2 years, 1 year, or 6 months.

[Application] If you hope to make 2 years prepayment from April, submit your application form to the Pension Office so it will arrive by the end of February. Your application must arrive by February 6 (Fri) if you submit your application form to the Insurance and Annuity Div.

[Others] If there are any problems with the documents, the deduction may not be completed in time.

Payment by direct debit can be arranged online at Japan Pension Service website via My Number Portal website.

To help with rising prices, the national government will offer special one-time payments of 20,000 yen per eligible child in order to support child-rearing households.

- 1) Children eligible to receive the child allowance for September 2025 and children born in September 2025 and eligible to receive the child allowance for October 2025; and
- 2) Children born from October 1, 2025 to March 31, 2026
