Eligibility Criteria for 400 mL Blood Donation

Ages: 17~69 years old for men, 18~69 years old for women

Note: Persons over 65 should have experience of blood donation after the age of 60.

Body weight: At least 50 kg for both men and women

Medicine: Most medications for high blood pressure, hyperlipidemia, and allergies do not disqualify you from

donating your blood. You can take your medication on that day. Please ask the staff at the reception

desk regarding other medications.

Note: Eligible blood donors who received a COVID 19 vaccination (RNA vaccine including mRNA vaccine)

must wait 48 hours before giving blood.

People who receive welfare allowance(s) are requested to submit an income report declaring their income of the previous year and their family circumstances with regard to child-rearing. A detailed letter will be sent out to eligible persons in advance. Please submit the necessary documents to the division in charge. Please keep in mind that payment of allowance(s) will be suspended if the income report is not submitted.

Allowances: 1) Allowance for persons with severe disabilities, who require in-home care

- 2) Special disability allowance, the disabled child welfare allowance and the transitional welfare allowance
- 3) Special child-rearing allowance

Deadlines: Aug. 1 (Mon) through Aug. 31 (Wed) for allowance 1) above

Aug. 12 (Fri) through Sept.12 (Mon) for allowances 2) & 3) above.

The divisions in charge of these allowances are closed on Saturdays, Sundays, and holidays.

Life Support Special Benefit for Child-rearing Households

(子育て世帯生活支援特別給付金を支給します。)

Parenting Assistance Div. 20561-73-4183 F 0561-72-4603 E-mail kosodateshien@city.nisshin.lg.jp With consideration to COVID-19 impacts, special benefit shall be provided to child-rearing households with low incomes in order to support their life.

• Eligible children: Children who are being reared by persons eligible for the benefit and were under the age of 18 (under 20 for disabled children) as of March 31, 2022.

Note: Babies born between April 1, 2022 and February 28, 2023 are also eligible.

• Persons eligible as recipients of the benefit:

- (1) Single-parent households:
 - (a) Persons who have received child rearing allowance for April 2022;
 - (b) Persons who have not received child rearing allowance for April 2022 because they are receiving public pension; or
 - (c) Persons whose income has dropped, due to the COVID-19 impacts, to the same level as recipients of child rearing allowance.
- (2) Households other than single-parent households:
 - (a) Persons who have received child allowance or special child rearing allowance for April 2022, and are exempt from per capita basis of resident tax for fiscal 2022; or
 - (b) Persons who do not fulfill requirement (2)(a), but are rearing an eligible child/children and fulfill either of the following requirements:
 - (i) Persons who are exempt from per capita basis of resident tax for fiscal 2022; or
 - (ii) Persons who are so affected by COVID-19 impacts that their income has dropped to the same level as those who are exempt from per capita basis of resident tax for fiscal 2022.

Note: Although directors of welfare facilities are not eligible as recipients of the benefit, foster parents are eligible if they fulfill any of the requirements above.

• Allowance: 50,000 yen per eligible child

• How to apply for benefit:

(1) No application is required for persons who fulfill requirement (1)(a) or (2)(a);

Note: If you are a public official and are exempt from per capita basis of resident tax for fiscal 2022, you are required to submit an application for the benefit.

(2) Application is required for persons who do not fall under (1) above:

Check detailed requirements for receiving the benefit on the Nisshin City Website, and submit your application to Parenting Assistance Div. of the City no later than February 28 (Tues), 2023.

• Date of payment:

- (1) Persons fulfilling requirement (1)(a) or (2)(a): A notice with the date of payment will be sent to you;
- (2) Persons other than (1): The benefit will be paid to you soon after your application is approved.

Recipients of childcare allowance, Aichi Prefectural orphan's allowance, and Nisshin City allowance for single-parent families need to submit a Current Condition Form and Income Report to confirm their rearing situation. Those who have been certified as recipients for the subsidy for medical expenses for single-parent households need to apply for renewed certificates. The forms will be sent out to those concerned in late July, so please don't forget to take steps. Recipients for the subsidy of medical expenses for single-parent households who are also recipients of childcare allowance, Aichi Prefectural orphan's allowance, and/or Nisshin City allowance for single-parent families will receive notice of Current Condition and necessary forms together with the form for Renewal Application of Medical Expenses.

Nisshin Life Support Benefit to Be Offered (にっしんくらし応援給付金を支給します)

Nisshin City will independently provide a benefit of 100,000 yen to households to which only per capita basis of resident tax is levied for fiscal 2022, but which do not fulfill requirements for recipients of the state's temporary special benefit for households exempt from resident tax.

- Eligibility: Persons who were registered in the Basic Resident Register as of December 10, 2021 and are heads of households fulfilling (1) or (2) below:
 - (1) Households which were registered in Nisshin City as of the base date (June 1, 2022) and whose members consist of those who fulfill either of the following requirements:
 - *those to whom only per capita basis of resident tax is levied for fiscal year 2022 (calculated based on the member's income in 2021); and/or *those who are exempt from resident tax for fiscal year 2022.
 - (2) Households which were registered in Nisshin City as of the date of application, and which do not fulfill the requirements for (1), but fulfill all of the following requirements:
 - (a) Households which have a member whose income has dropped in or after January 2022 due to COVID-19 impacts;
 - (b) The income of the above member has dropped to the level for which only per capita basis of resident tax would be levied if the amount is converted to the annual income estimate;
 - (c) Household members other than the above member whose income has dropped are also taxed only for per capita basis of resident tax or are exempt from resident tax.

Note:

- ➤ The Nisshin Life Support Benefit shall not be provided to households which are eligible for the temporary special benefit which started in January 2022 for households exempt from resident tax including those experiencing sudden financial difficulties.
- ➤ Households whose members are all supported by other relatives who are subject to the per income base resident tax for fiscal year 2022 are not eligible despite fulfilling requirements (1) or (2).
- Those fleeing from domestic violence and reside in Nisshin City without resident registration and fulfill requirements (1) or (2) are eligible for this benefit. Please refer to the section in charge for details.
- Allowance: 100,000 yen per household
 - Note: The allowance will be included in the recipient's income gained in fiscal year 2022 which is subject to taxes.
- **Application:** Deadline: September 30 (Fri) for both (1) and (2)
 - (1) For households which fulfill requirements for (1): The confirmation documents have been sent out from late July. Please check the contents and send them back to Community Welfare Division using the enclosed envelope.
 - (2) For households which fulfill requirements for (2): Application forms are distributed at the window of Community Welfare Division or can be downloaded from the Nisshin City website. Send your application form with the following documents by post to Community Welfare Division with only the postal code, ∓ 470 -0192. No address is necessary.
 - A copy of the applicant's personal identification such as Driver's License, Health Insurance Card, and (the front side of the) Individual Number Card (My Number Card); A copy of the first page of your passbook of the account in which you wish to receive the benefits or a copy of your cash card; A simple statement with income estimates of household members (This form is distributed at the window of Community Welfare Division and can also be downloaded from the Nisshin City website); and A copy of a document which states the income gained in an arbitrary month from January, 2022 such as pay statement, notification of pension transfer and statement with the amount of business income.
