Hib, Pneumococcal, Hepatitis B, Rotavirus, BCG, Four kinds of vaccines (Diphtheria, Pertussis, Tetanus and the Inactivated Polio), the Inactivated Polio, DPT (Diphtheria, Pertussis, and Tetanus), DT (Diphtheria and Tetanus), MR (Measles and Rubella), Chickenpox, Japanese Encephalitis and HPV (cervical cancer vaccine) are given at the designated medical institutions in Nisshin. Vaccinations against the Omicron variant for people who meet all the conditions below will end on May 7. If you meet all the conditions below and wish to get vaccinated, please be sure to get vaccinated by May 7.

Conditions

- Persons who have not yet received vaccination against Omicron
- · Persons aged between 12 and 64 years old
- Persons without underlying medical conditions
- Persons who do not work at medical institutions, care homes for the elderly, or at nursing facilities

If you meet all these conditions and do not get vaccinated by May 7, you will not be able to get vaccinated until September or after September.

*No group-vaccinations are scheduled in April. Please visit a medical institution to get vaccinated. [About vaccinations starting in spring and autumn in 2023]

People who meet either one of high risk conditions 1)-3) will be able to receive vaccinations twice a year in programs for "Vaccinations to start from Spring" and "Vaccinations to start from Autumn".

- 1) Persons aged 65 and over
- 2) Persons aged 5 and over with underlying medical conditions
- 3) Persons who work at medical institutions, care homes for the elderly or nursing facilities for handicapped people People who do not meet any of conditions 1)-3) will be able to receive vaccination once a year in the program for "Vaccinations to start from Autumn".
- *Vaccinations in fiscal 2023 are free of charge.

1) desired type and date of examination; 2) address (with the postal code); 3) full name; 4) birthdate; 5) telephone number of the applicant; and 6) nursery service request as necessary, specifying the number and age(s) of child(ren).

Applications are processed on a **first come**, **first served basis**: Applicants who cannot get their desired screening(s) will be notified. Detailed information on screenings will be sent out 2 weeks prior to the screening date. For more information, please contact the Health Center.

NOTE: People in a municipal tax-exempt household or a household receiving welfare benefits are exempt from the fees of the examinations at the Health Center, osteoporosis screening and fluoride coating on teeth. A certificate and other documents are needed. For more information, please contact the Health Center. The educational grant will be provided to high school students who are determined to study so that they can have their education without anxiety regardless of their families' economic situation.

- **Eligibility** Persons who fulfill all three following requirements:
- Students who attend high school or another educational program
- Students and their parents who are registered as citizens of Nisshin City as of May 1st in the year of receiving the subsidy
- Students who cannot get proper high school education due to their family's financial situation, and also whose parents' total income falls into either of the following categories in the chart below.
- Application: Please submit 1) and 2) below to the Educational Affairs Div. The form for 1) is distributed at the window of the Educational Affairs Div. on the second floor in the Nisshin City Hall. It can also be downloaded from the Nisshin City Website.

NOTE: If the guardian was not registered as a resident as of January 1, 2023, a taxation certificate must also be submitted.

Subsidy for school lunches and school supplies (就学援助制度のお知らせ)

School Education Div. 20561-73-4145

Guardians who have financial difficulty paying for school lunches and school supplies for children in elementary or junior high schools may be able to receive a partial subsidy for these fees.

Eligibility: Persons who meet any of the following requirements

1) Persons who are totally or partially exempt from paying municipal tax. 2) Persons who are partially exempt from paying the premiums for National Pension Insurance. 3) Persons who are totally or partially exempt from paying National Health Insurance Tax. 4) Persons who receive Childrearing Allowance. 5) Persons who are on welfare loan. 6) Persons who need financial assistance for other reasons

NOTE: The income basis for households by number of persons is shown below. (The amounts are approximate and changes by composition of the household and deductions.) Two-person household: 2,300,000 yen, three-person household: 2,900,000 yen, four-person household: 3,250,000 yen, five-person household: 3,700,000 yen, six-person household: 4,100,000 yen.
