Fiscal 2024 Light Motor Vehicle Tax Notice (category-based tax reduction) to be Sent out in Early May

(5月上旬に令和6年度軽自動車税(種別割)の納税通知書を送付します。)

You can pay the Light Motor Vehicle Tax at convenience stores and via the local tax payment website as well as financial institutions.

Reduced tax rates will be applied to four-wheeled light vehicles, which have undergone their initial inspection in fiscal 2023 and proven to meet designated environmental performance criteria, according to their fuel and emission efficiencies only for tax payment in fiscal 2024.

Question: Why have I received a tax payment notice for a vehicle I don't possess now? Do I have to pay the tax again this year?

Answer: The Light Motor Vehicle Tax (category-based tax reduction) is levied on owners or users as of April 1 each year regardless of whether they actually own or use the vehicle. If the proper procedures of deregistration have not been taken before then, the vehicle will be regarded as being registered and the owner is liable for taxation. Be sure to promptly deregister a vehicle when you stop owning or using it to avoid taxation.
