A detailed letter will be sent out to eligible persons in advance. Please submit the necessary documents to the division in charge. Please keep in mind that payment of allowance(s) will be suspended if you fail to do so.

The Child Allowance System will be partly revised on October 1, 2024 to cover more children and provide greater amounts more frequently.

First payment after the revision is due on December 9 (Mon) 2024.

Application is necessary for the following persons

Those who did not receive payment (child allowance or special benefits) until September 2024 and who will become eligible by the revision need to apply.

1. Those who did not receive payment due to income higher than the limit

Notices will be sent to those who received notices of termination or rejection in the past. Apply using the enclosed form. Please confirm and apply on your own if you do not receive a notice.

2. Those rearing children of high school age but not rearing younger children

Notices will be sent (at the end of August) to households rearing only children of high school age as of August 1, 2024. Apply with enclosed form.

Please confirm and apply on your own if you have such a child in a separate household, or if you have moved into Nisshin on or after August 1, 2024.

Procedures vary for those who receive payment (child allowance or special benefits) up to September 2024.

1. Those rearing only children in junior high school and younger children:

No procedures are required. A notice will be sent to you in October or after if your monthly amount changes by the elimination of income limit or changes in additional payment for many children.

2. Those rearing children of high school age

> In case the child is in the same household

No procedures are required in principle. A notice with the monthly payment amount including children of high school age will be sent in or after October.

> In case the child is in a different household

If you have not declared separate custody, application for increased amount is needed.

If you have submitted a declaration of separate custody with your current status report for fiscal 2024, this is not necessary.

3. Those who have 3 or more eligible children including a child (or children) up to the first March 31 after reaching the age of 22

An application for additional allowance for households with many children should be submitted.

You will receive a notice about the allowance if the older child is in the same household as of August 1, 2024. You must confirm and take procedures on your own if that child is in a separate household or has become part of your household after August 1, 2024.

X Even if the older child is living separately, the parent or guardian (the recipient of the child allowance) is subject for additional payment for many children, if she/he is supporting the child financially.

(Financial support includes cases where the parent or guardian bears at least part of the tuition, rent, and food expenses including remittance.)

Recipients of childcare allowance, Aichi Prefectural orphan's allowance and/or Nisshin City allowance for single-parent families need to submit a current conditions form and an income report to confirm their child-rearing situation. Those who have been certified as recipients of the subsidy for medical expenses for single-parent families need to apply for renewed certificates. The forms will be sent out to those concerned in late July. Please don't forget to take steps. Those who need to submit both the current conditions form and the form for renewal application for medical expenses will receive the documents together by post.

Notification period: August 1 (Thurs) through August 30 (Fri) excluding Saturdays, Sundays and holidays

Eligibility: Single parents or similar families raising children who will reach the age of 18 at the end of the fiscal year (March 31, 2025) or younger children. Similar families include cases where the father or mother is severely disabled or where children have been abandoned by the father or mother for over a year.
